

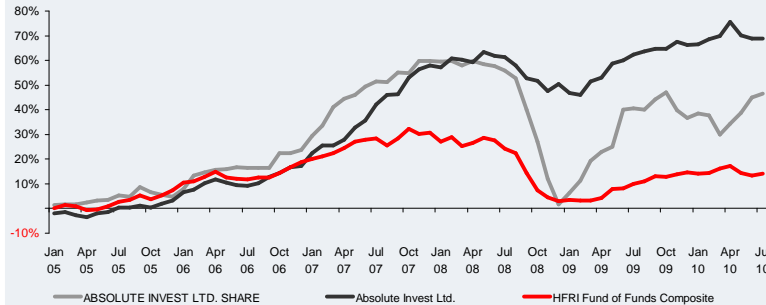
**FUND DESCRIPTION**

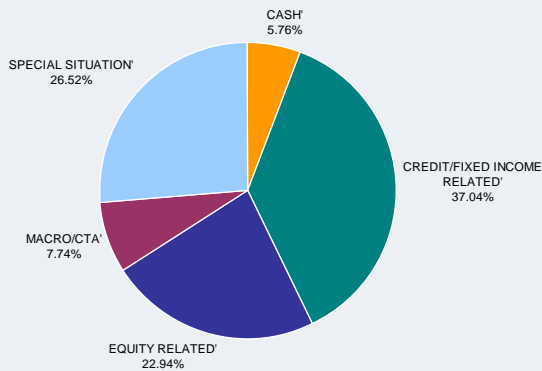
